

**“I Want You To Show Me” Campaign
PARTICIPATION TERMS**

MUST BE 18 YEARS OF AGE OR OLDER TO PARTICIPATE. NO PURCHASE NECESSARY TO PARTICIPATE.

WHO MAY SUBMIT A RECORDING: The “I Want You To Show Me” Campaign (“Promotion”) is open to legal residents of the fifty (50) United States and the District of Columbia, who are at least 18 years of age. Void where prohibited or restricted by law. Officers, directors and employees of any of the following: Rhino Entertainment Company (“Sponsor”), Warner Music Group, the performing artist professionally known as “Foreigner” (“Artist”) and other individuals and entities responsible for the development, promotion and implementation of this Promotion, and their respective suppliers, parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate family (spouses, parents, children and siblings, and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such non-eligible individuals, are not eligible to submit a Submission (as defined below). Promotion is subject to all applicable federal, state and local laws. Sponsor’s decisions are final and binding on all matters relating to this Promotion.

HOW TO MAKE A SUBMISSION: During the Promotion Period (as defined below), either visit www.iwtkwli.com and follow the directions to complete the online form provided, or call 662-498-5854 to submit an original audio recording no longer than thirty (30) seconds in length that describes what love is (each, a “Submission”).

All Submissions must be submitted during the Promotion Period (as defined below) to be considered. Submissions generated by script, macro or other automated means and Submissions made by any means which subvert the participation process are void. All Submissions must adhere to these Participation Terms, including but not limited to the guidelines set forth in the Submission Content Restrictions section below, to be eligible.

Submissions will be accepted between 9:00:00 a.m. Eastern Time (“ET”) on December 9, 2024 and 11:59:59 p.m. ET on February 28, 2025 (“Promotion Period”). Only Submissions received during the Promotion Period that are otherwise fully compliant with these Participation Terms are “Valid Submissions.” Limit of one (1) Submission per person throughout the Promotion Period. In the event of a dispute involving Submissions submitted by multiple individuals using the same phone number, the Submission will be deemed to have been submitted by the authorized subscriber of the phone number used to enter the Promotion at the time of Submission. The authorized subscriber is defined as the natural person who is assigned to an phone number by the relevant phone service provider, online service provider or other organization responsible for assigning the respective phone number.

SUBMISSION CONTENT RESTRICTIONS:

A Submission may not contain, as determined by the Sponsor, in its discretion, any content that:

- is sexually explicit or suggestive;
- is violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic;
- promotes illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message;
- features, advocates, suggests, condones or treats in a humorous manner the excessive, underage or irresponsible consumption of beverage alcohol products;
- is obscene or offensive; endorses any form of hate or hate group;
- defames, misrepresents or contains disparaging remarks about other people, companies or products;
- contains any sensitive personal information or identification, such as license plate numbers, personal names, e-mail addresses or street addresses; contains copyrighted materials owned by others (including photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media with the exception of Sponsor products);
- contains materials embodying the names, likenesses, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead; and/or
- violates any federal, state or local laws, including without limitation, copyright laws.

Submission must be in English and the original work of the participant (with the exception of the permitted third-party materials provided by Sponsor to participants on the Promotion website). The Submission may not have been previously published, and may not have won previous awards. By submitting a Submission,

participant warrants and represents that he/she consents to the recording of their voice and use of the Submission in this Promotion and to its use as otherwise set forth herein.

DETERMINATION OF FINALISTS: Sponsor will review Valid Submissions and determine, in its sole discretion, up to thirty (30) Valid Submissions to include in the Finalist Montage, if any (each, a "Finalist").

NOTIFICATION OF FINALISTS: Each Finalist may be required to sign an affidavit of eligibility and publicity/liability release and any other documents required by Sponsor within five (5) business days of initial notification, if so notified. Sponsor notification shall be deemed to have occurred on the date Sponsor or Sponsor's designee first attempts to make contact with a potential Finalist. If any potential Finalist is found to be ineligible for any reason, an alternate may be selected. If notification is returned as undeliverable, it will result in disqualification. Sponsor is not responsible for unsuccessful efforts to notify any potential Finalist.

FINALIST MONTAGE: Sponsor shall have the perpetual, worldwide, sublicensable, royalty-free right and license to record, re-record, transcribe, broadcast, edit, copy, publicly perform, display, synchronize, create derivative works from, and otherwise use the Submission, in whole or part, in any and all media, including, without limitation, to use the Submission in audio and/or audiovisual work(s) created by or on behalf of Sponsor for promotional purposes ("Finalist Montage"). Inclusion of any Finalist's Submission in any work has no cash value and will not be subject to or give rise to any royalty, licensing fee, residuals, or other fees. Sponsor does not guarantee the opportunity for any portion of a Finalist's Submission to be included in any Sponsor materials and does not guarantee the Finalist Montage, or any other Sponsor materials using a Submission, will be made public.

GENERAL: By participating, all participants warrant and represent that they have complied in full with these Participation Terms, including but not limited to all eligibility requirements, and further agree to be bound by these Participation Terms and the decisions of Sponsor and/or the judging organization or entity, which are final and binding in all respects. All Submissions become the property of Sponsor and will not be returned or acknowledged. Photocopies, facsimiles, and incomplete or mechanically reproduced Submissions are not eligible. Submission materials that have been tampered with or altered, or mass Submissions or Submissions generated automatically or robotically, or by a script, macro or use of any automated device(s) are void. Neither Artist, Sponsor nor its parents, affiliates, subsidiaries, divisions and/or advertising or promotion agencies are responsible for: (i) lost, late, misdirected, or damaged Submissions; (ii) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of Submission materials or online voting data, as applicable, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive Submission or voting information by Sponsor; (iii) hardware or software errors; faulty computer, telephone, cable, satellite, network, electronic, wireless or Internet connectivity or other online communication problems; errors or limitations of any Internet service providers, servers, hosts or providers; garbled, jumbled or faulty data transmissions; failure of any e-mail or online fan voting transmissions to be sent or received; lost, late, delayed or intercepted e-mail transmissions; inaccessibility of the website in whole or in part for any reason; traffic congestion on the Internet or the website; unauthorized human or non-human intervention of the operation of the Promotion, including without limitation, unauthorized tampering, hacking, theft, virus, bugs, worms; or destruction of any aspect of the Promotion, or loss, miscount, misdirection, inaccessibility or unavailability of an account used in connection with the Promotion; or (iv) any injury or damage to participant's or any other person's computer related to or resulting from entering or otherwise participating in the Promotion. WARRANTY: By entering, each Participant warrants and represents (i) that the participant owns all rights to the Submission they are entering in this Promotion, including, without limitation, the video or digital recording, and the performance contained in each Submission, with the exception of any Sponsor brand assets provided or made available by the Sponsor for use by participants in connection with this Promotion; (ii) that the participant is the individual pictured and/or heard in the Submission, or, alternatively, that the participant has obtained permission from each and every person featured in the Submission, granting full exhibition rights to the Sponsor as described in these Participation Terms, and can make written copies of such permissions available to the Sponsor upon request; (iii) and that their Submission: (a) is original to the participant (with the exception of the permitted third-party materials provided by Sponsor to participants on the Promotion website) and has been legally obtained and created, (b) does not infringe the intellectual
